Press Release: MASTIO publishes the 29th Edition Natural Gas Pipeline Report.

MASTIO is pleased to announce the publication of the 2025, 29th Edition of the industry-wide Natural Gas Pipeline Customer Value & Loyalty Benchmarking Study. The study, released to subscribers in late February, provides comprehensive insights into interstate, intrastate, and Canadian pipelines.

Based on 745 in-depth interviews with industrial customers, local distribution companies (LDCs), independent power producers, producers, and marketers, this study evaluates pipeline performance across 29 key attributes. These include responsiveness, after-hours support, reliability of firm gas transportation, problem resolution, overall company performance, and likelihood of recommending a pipeline.

In addition to quantitative metrics, the study captures qualitative insights through open-ended questions. Respondents share their perspectives on critical decision-making factors, including:

- "Besides price, what is the most important factor you consider when selecting a transportation provider?"
- "What has been your biggest disappointment with each of your pipelines over the past 12 months?"

This comprehensive analysis helps pipeline operators understand customer expectations, identify areas for improvement, and enhance overall service quality.

The most crucial issue to transporters of natural gas in the latest study is firm gas transportation is highly reliable.

Top 5 Customer Needs

- 1. Firm gas transportation is highly reliable.
- 2. Scheduled gas volumes are accurate.
- 3. Accuracy of invoices.
- 4. Communicates in an honest and forthright manner.
- 5. Representatives are accessible when needed.
